Technology Centre Inaugurated



Shah Indubhai Dahyabhai and Shah Girishchandra Dahyabhai Technology Centre for the Blind was inaugurated by the donor family on 8 October 2024. The Indubhai Dahyabhai Family has earlier donated for the setting of the Indubhai D. Shah and Vipinchandra D. Shah Handika Furniture showroom. Mrs. Usha Atulkumar, President of Adult Training Centre for the Blind Trust and Trustee of BPA was responsible for mobilizing both these donations. The Technology Centre teaches computer skills to visually impaired people. It also trains them in accessibility testing. The Centre has been responsible for placing around 50 visually impaired persons in banks in the past year.

BGSS Distribution

MD & CEO, Ms. Sumit Chadha and COO, Mr. Srinivas Panda distributed high tech devices like Orbit Braille Readers to 15 youth with visual impairment empowering them to compete with the sighted world on 10 OCTOBER 2024 The Orbits are a braille display, and connect to PCs and Macs, iOS devices and Android devices. They provide Bluetooth and USB connectivity and can connect simultaneously to multiple devices. Thus all information becomes accessible to persons with visual impairment. Perkins Evaluation Visit



BPA and Perkins India are working collaboratively to increase access to quality education for children with disabilities in 3 to 5 schools (Government/ Non-Government) in Gujarat in 2024 by increasing the capacity of teachers and program staff working with children with disabilities to provide quality educational interventions to them based on Perkins Quality Improvement (PQI) framework.

The Perkins Quality Improvement process is both an assessment tool and an approach to quality education. Developed ten years ago, the Quality Improvement process stems from Perkins' 200 years of expertise and knowledge in educating children with disabilities. It has been applied to schools and programs around the world to drive change, transform systems and support educational excellence.

The pilot project will enhance the capacity of government and non-government schools to become models of inclusive education for children with disabilities having a trained cohort of teachers and educators who are equipped with the knowledge and skills they need to effectively teach children with disabilities. Samapada and Anuradha of Perkins visited BPA and the offshoot centres at Deesa, Sala and Bavla on 7, 8 October 2024 to evaluate the efficacy of the Perkins Quality Improvement (PQI) framework.

ICEVI WORLD CONFERENCE IN INDIA

Mrs. Binaben Kaivalya Baxi and Mr. Dinesh Ramanlal Shah were executors of their friend Naliniben's will. In accordance with her wishes, they have pledged Rs. 1 crore for naming one floor in the proposed new building of the BPA Ladies Hostel. The floor will be named as the Smt. Naliniben Purohit Memorial Floor. Binaben and Dineshbhai visited the BPA on 17 October, 2024 and signed an MoU in this regard and donated Rs. 50 lakhs as the first instalment.



The International Council for Education of People with Visual Impairment (ICEVI) held its World Conference and General Assembly in Ahmedabad India from 14 – 17 November 2024. The World Conference was hosted by the Blind People's Association (BPA) and Sense International India (SII), in collaboration with Dr. Babasaheb Ambedkar Open University (BAOU), Ahmedabad, which is renowned for its higher education program promoting "Education for All". The University campus was the venue for the conference. The Conference Theme was "INCLUSION IN DIVERSITY: EQUITY AND ACCESSIBILITY FOR ALL".

The Preconference was organized on 13 November at the BPA campus and had three Workshops. The first was led by Ms. Sampada Shevde of Perkins and was titled "UNDERSTAND THAT ALL BEHAVIOURS COMMUNI-CATE" - Communication for Persons with Visual Impairment and Additional Disabilities Including Deafblindness. The last workshop titled "Importance of Independent Living for Persons with Deafblindness" was organized by Sense International India. There was also a demonstration and distribution of "Jyoti AI: Advancing Education and Independence for the Visually Impaired" by TORCHIT. The Conference was inaugurated by the Officials of the ICEVI, Deafblind International, World Blind Union along with the Vice-Chancellor of BAOU. Ambassador Aubrey Webson and Dr. Ami Upadhyay of BAOU gave the powerful Keynote addresses. Shri Rajesh Kumar Secretary, Ministry of Social Justice and Empowerment, could not attend and inaugurate the conference and sent his recorded address.

383 participants from 59 countries participated. A total of 152 speakers presented their thoughts through 6 Plenary and 24 concurrent sessions.

Ms. Siân Tesni, Chair of the Programme Committee with her team ensured that there was representation from all over the world and that deafblindness, multiple disability was covered along with visual impairment.

Nandini Rawal, the Former Treasurer of ICEVI and a recipient of ICEVI's International Excellence Award in 2016, was appointed by the Executive Board to Chair the 2024 Awards committee. Nandini, in consultation with the President ICEVI, invited members from the Executive Board to serve as members of this Committee. The Presidents of each region were invited to submit nominations for ICEVI awards which were conferred on winners at the ICEVI World Conference.
